TUESDAY, JULY 15, 2014 MEETING MINUTES

Introduction

The Harbour Waterway Special District (HWSD) meeting of the Board of Supervisors was held at the Resurrection Episcopal Church on July 15, 2014. The meeting was called to order at 7:00 PM by Chairman William Hibbard. In attendance were William Hibbard, Paul Stroup, Robert Birtalan, Robert Schleef and Stanley Pipes. It was noted that there was a quorum present. Attorney Brenna Durden was present on behalf HWSD Attorney Wayne Flowers. Kathryn Boucher was present as recording secretary.

Public Hearing

2014 non-Ad Valorem Tax Assessment – No members of the public were present. The proposed assessment was presented to the board for review. There is one change from the previous year; an additional parcel was added to the tax roll. 1100 Harbour Cay Court was subdivided, with the smaller parcel having no canal access. The new property is being assessed at zero. The total assessment comes to \$215,000. The public hearing was closed at 7:05.

Administrative

Approval of Minutes from June 10, 2014 – Motion made to approve the minutes as written; motion passed.

District Business

2014 non-Ad Valorem Tax – Due to Property Appraiser July 25th – Motion made to approve resolution 2014-03 as written; motion passed unanimously.

Annual Audit begins July 1st – Due on within 90 days of the end of the fiscal year.

"Form 1" Due to Supervisor of Elections on or before June 30. Penalties apply for late submissions. – The board members have all submitted their forms.

Election Year for Board of Supervisors Seats 2 and 4 – Both current board members have registered as candidates.

William Hibbard announced his resignation from the board. He will be closing on the sale of his home later this month. He will submit a letter of resignation to the board, as well as the required financial

disclosure to the Supervisor of Elections. Mike Levi has voiced an interest as a candidate for the board seat vacated by Bill Hibbard. The website information will be given to Stanley Pipes to maintain.

Ordinance 2010-725-E Amendment – Regulations on Dock & Bulkhead Construction – Stanley Pipes met with Clay Yarborough and city attorney Jodie Brooks to discuss proposed amendments to the ordinance. In the proposal, the board will be enforcing the covenants and restrictions previously administered by the HWA, as well as building codes for new construction in relation to the canal. Clay approved of the HWSD being responsible for the standards in the canal system, rather than the city council. Jodie Brooks brought up potential issues with the right of the HWSD to move boats during a dredge, as it could be considered the seizure of private property by a government agency. She will work with HWSD attorney Wayne Flowers to come up with another means of enforcement, such as a daily fine. Jodie and Clay were very sympathetic to the needs of the HWSD board. Jodie Brooks asked for a couple weeks to draft the legislation, which Clay Yarborough will then submit to the city council. Stanley Pipes will put together the new construction minimum standards for the board to review.

Spoil Site Procurement – Reed Island – This issue remains on the table. William Hibbard and Mike Brandy volunteered to work as a committee to address this issue. Stanley Pipes brought up the issue with Clay Yarborough in their meeting.

<u>Financial</u>

Approval to disburse funds for Legal and Administrative Services – Motion made to approve disbursement of \$516.00; motion passed. The projected ending balance after disbursements and debt service (payable in November) is \$49,027.07.

RESOLUTION NO. 2014-03

A RESOLUTION OF THE HARBOUR WATERWAY SPECIAL DISTRICT, DUVAL COUNTY, FLORIDA, ADOPTING A NON-AD VALOREM ASSESSMENT ROLL FOR 2014 AND LEVYING NON-AD VALOREM ASSESSMENTS ON LOTS AND PARCELS IN THE DISTRICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on February 7, 2012, the Board of Supervisors ("Board") of the Harbour Waterway Special District ("HWSD") approved a duly noticed Resolution adopting the Uniform Method for Collecting Non-Ad Valorem Assessments, in conformance with Section 197.3632, Florida Statutes; and

WHEREAS, on June 30, 2014, a notice was published in a newspaper of general circulation in Duval County, Florida, giving notice of the date, time and location at which a public hearing would be conducted to consider adoption of a Resolution approving the non-ad valorem Roll for the HWSD as well as imposing non-ad valorem assessments on the lots and parcels in the HWSD for fiscal year 2014-2015; and

WHEREAS, a public hearing was conducted on this date, consistent with the notice provided by publication, at which testimony was received by the Board of Supervisors for the HWSD ("Board") regarding the proposed non-ad valorem assessments on lots and parcels in the HWSD; and

WHEREAS, the Board finds that the purpose of the non-ad valorem assessments approved through this Resolution is to provide funds for conducting maintenance dredging of the system of canals located in the HWSD and to dispose of the dredged material removed from the canal system in connection with the maintenance dredging, a purpose consistent with the authority given to the HWSD in City of Jacksonville Ordinance No. 2010-725-E; and

WHEREAS, the Board finds that the non-ad valorem assessments approved through this Resolution, which are the same as the non-ad valorem assessments imposed for fiscal year 2013-

2014, will benefit all properties assessed as a consequence of the maintenance dredging project and further finds that the non-ad valorem assessment approved through this Resolution is fairly and equitably apportioned among the properties receiving the benefit of the maintenance

NOW THEREFORE, Be it Resolved by the Board of the HWSD that:

Section 1. The Non-Ad Valorem Assessment Roll attached hereto as Exhibit "A" is hereby certified and the assessments specified thereon are adopted for the lots and parcels listed thereon for Fiscal Year 2014-2015.

Section 2. This Resolution shall become effective upon adoption.
