TUESDAY, JUNE 7, 2016 MEETING MINUTES

#### Introduction

The Harbour Waterway Special District (HWSD) meeting of the Board of Supervisors was held at the Resurrection Episcopal Church on June 7, 2016. The meeting was called to order at 7:00 PM by Robert Birtalan. In attendance were Robert Birtalan, Robert Schleef, and Stanley Pipes. It was noted that there was a quorum present. HWSD attorney Wayne Flowers was present. Kathryn Boucher was present as recording secretary.

#### Administrative

Approval of Minutes from May 10, 2016 – Motion made to approve the minutes; motion passed.

#### **District Business**

Spoil Site Procurement – Reed Island – City Councilman Al Ferraro was present. He presented the board with a tentative agreement for the purchase of the Reed Island property from JaxPort, which the Executive Director of the port is going to present to his board for approval. The sale price has not yet been determined. The agreement designates the land to be used as a spoil site, but the property is currently zoned as residential which makes it unusable as a spoil site. There is a clause that allows for other districts to use the site for spoil at the market rate. The board will look over the document and submit any corrections or concerns back to Al Ferraro for a revision to be made prior to the next board meeting.

#### **Public Notices:**

Meeting Schedule – The schedule of the board meetings for the next year was presented to the board. Motion made to approve; motion passed. The schedule will be published.

Public Hearing for the Adoption of 2016 Non-Ad Valorem Assessment – This will be held during the regular scheduled July 12<sup>th</sup> meeting, as long as there is a quorum. The final assessment is due to the city July 31<sup>st</sup>.

FDEP Easement – The name change on the easement was approved and the permit will be valid for the next 8 years.

Dredging Permit - Stanley Pipes will follow up on changing the name on the permit.

Form 1 due by July 1, 2016 – The board members were reminded. The forms may be submitted now. There is a note on the form regarding ethics training, but this does not apply to special districts.

#### **Financial**

FY 2016-17 Budget Approved by the Finance Committee – May 16; 2016-311 – Stanley Pipes attended the finance committee meeting on May 15<sup>th</sup> where the budget was approved.

2015 HWSD non-Ad Valorem Assessment – Status - 94% of funds have been collected, for a total disbursement of \$188,009.03. 7 properties have not yet paid.

2016 HWSD non-Ad Valorem Assessment – Tax roll due July 31 – The tax roll was sent out. One property had been left out and the official roll was corrected. The assessment amounts will remain the same as last year. There is a property at the end of Harbour Cay which is listed as two separate parcels, one of which is owned by the bank; this property is assessed at zero.

Approval to disburse funds – Motion made to approve disbursements for legal services, transfer of the FDEP easement and administrative services totaling \$1,489.00; motion passed. After all projected debt service and the projected assessment collection, the total of the disposable funds remaining in the BB&T checking account is \$129,666.01.
