TUESDAY, JUNE 12, 2018 MEETING MINUTES

Introduction

The Harbour Waterway Special District (HWSD) meeting of the Board of Supervisors was held at the Resurrection Episcopal Church on June 12, 2018. The meeting was called to order at 7:02 PM by Robert Birtalan. In attendance were Robert Birtalan, Michael Levi and Stanley Pipes. It was noted that there was a quorum present. Harbour Waterway attorney Wayne Flowers was present. Kathryn Amason was present as recording secretary.

<u>Administrative</u>

Approval of Minutes from May 8, 2018 – Motion made to approve the minutes as written; motion passed.

District Business

Reed Island – City of Jacksonville Parcel – City Councilman Al Ferraro is planning to call a meeting with the mayor and the chair of the Waterways Commission to discuss the Reed Island parcel.

2017 Form 1 – Due to Supervisor of Elections by July 2 – The board members were reminded.

2018 General Election – Board Seats 1, 2 & 4 up for re-election – Seat 1 is currently vacant. It has been confirmed to be on the upcoming ballot. A resolution was introduced to nominate David Prysock to replace Robert Schleef as Board Seat 4; resolution passed.

2018 – 2019 Meeting Schedule – The fiscal year ends on June 30th. All meetings will be held on the second Tuesday of each month. There was a discussion about adjusting the schedule due to regular conflict with City Council meetings and the Harbour North Civic Association. A special session could be called with two days' notice to accommodate attendance by City Councilman Al Ferraro. Motion made to adopt the 2018-2019 schedule as presented; motion passed.

Waterway Rules & Dock Approvals – There are no new applications to discuss.

Financial

HWSD non-Ad Valorem Assessment:

2017 non-Ad Valorem Assessment - Status - 98.6% of the assessment has been collected, for a total distribution of \$197,201.26. Two properties remain outstanding. Tax certificates are issued in June.

2018 non-Ad Valorem Assessment due August 1 – The tax roll was received from the tax assessor and was presented to the board. There are no proposed changes from the prior year. During the public meeting next month there will be a vote held to approve the assessment. The different levels of the assessment were explained.

Annual Audit begins August 1 – The audit will be done by CPA Mr. Robert M. Thaggard, who conducted the audit last year.

Approval to disburse funds – Motion made to approve disbursements for a QuickBooks upgrade, administrative and legal services totaling \$1,090.95; motion passed. After the projected debt service and the projected revenue from the 2017 assessment the total of the disposable funds remaining in the BB&T checking account is \$266,537.49.

District Schedule

Next Scheduled Board Meeting – The next meeting will be July 10, 2018 at Resurrection Episcopal Church.

Public Hearing for 2018 non-Ad Valorem Assessment – Scheduled for July 10 at Resurrection Episcopal Church.

Other Business

Legal and Compliance Issues - None to discuss.

Isle of Palms – According to their meeting minutes, the Isle of Palms proposed a \$1 per cubic yard tipping fee, which is below the HWSD's planned rates. The tipping rate schedule set by the board ranges from \$10-\$5 per cubic yard, as presented during the May meeting. Tarpon Springs, Reed Island Estates and Millers Creek have expressed interest and have been given the tipping fee rate schedule. It is expected that the spoil site will not be used before the end of 2018. It is estimated that the HWSD will need to reserve about 300,000 cubic feet of space for their own needs.

There was a discussion about clearing the Reed Island parcel. The Army Corps of Engineers is planning a project to spray for an invasive species "salt cedar (Tamarix)" on Reed Island. We have agreed to cooperate with their project.

There was a discussion about methods that could be used to repair the breakwater/bulkhead in order to slow the silting of the Mill Cove channel. Positioning boom with attached silt screens along the bulkhead or geotextile tubes would only be a temporary solution until the bulkhead could be repaired. The current bulkhead is approximately 1,500 feet long along both sides of the channel through Mill Cove. A complete repair project would take an estimated two to three months; finding a contractor available to do the project could be a challenge due to the backlog from the hurricane. The different materials that could be used were debated. Any projects will be dependent on the availability of funds. The board briefly discussed purchasing or leasing a small 8 inch maintenance dredge, which would necessitate hiring operators and securing Jones Act insurance.

The current dredging permit with the USACE expires on December 28, 2022. The board discussed modifying the permit to allow for mechanical spot dredging as well as hydraulic dredging. The process of modifying the permit is expected to take several months. Under current conditions, a partial dredge or "eco-restoration" to the "T" will not be completed for another two years. The minimum expected cost of the eco-restoration is approximately \$650,000 to remove approximately 40,000 cubic yards.

Comments and Questions from the Audience

There was a discussion about alligators in the canal. There was a dead alligator in the canal that was towed out into the river.

There was a question about damaged docks in the canal. It was suggested that photos should be taken of questionable docks for the board to review.

Adjournment

The meeting was adjourned at 8:19 PM. The next monthly Board of Supervisors meeting is scheduled for July 10, 2018.
