Meeting Minutes

Tuesday, November 13th, 2025

I. Introduction

The Harbour Waterway Special District (HSWD) meeting of the Board of Supervisors was held on November 13th, 2025, at Resurrection Episcopal Church. The meeting was called to order at 6:01 pm. In attendance were Rick Fornos, Mike Brande, Bob Birtalan, Wally Lovely, Mark Todd and District Manager Stanley Pipes. It was noted that there was a quorum present. Harbour Waterway attorney Wayne Flowers was present. Caroline Goodrich was present as recording secretary.

II. Administrative

Approval of minutes from October 9th, 2025 – A Motion was made to approve the meeting minutes; Motion Carried.

III. District Business

JEA Tower raising project – The JEA construction on Reed Island continues to make progress daily. 8 of 12 concrete supports for the 400ft towers have been poured. The last 4 supports should be poured within the next 2 weeks.

Spoil Site Disposal – Various new dredging projects are currently in the works.

HWSD Marina- The US Army Corp of Engineers has issued the necessary permit for the boat ramp. Top Dog Marine estimates construction to resume in 6-8 weeks. Once construction has begun, 60 – 90 days is the estimated completion time.

Southern Bulkhead Replacement- Fincantieri awaiting DOT approval for material removal at their shipyard.

Amendment to Ordinance – The HSWD submitted an amendment to Ordinance 2023-351 that requires the Reed Island work to be completed within 3 years of the ordinance passing date, which would be June of 2026. Due to the JEA project, HSWD requested an amendment to the ordinance. The City Council passed the amendment to Ordinance 2023-351 that extends the completion date to June of 2029. A motion was made to approve resolution 2025-09; Motion Carried.

Waterway rules and regulations- No current news.

IV. Financial

2024 non-Ad Valorem Tax Rebate – After review, a motion was made to approve Resolution 2025-08; Motion Carried. The 2024 tax rebate is the same as last year's rebate.

FY 2024-25 Audit – The audit will begin in December and will take an estimated 6 weeks to complete.

A motion was made to approve the requested disbursements for District Manager billing, Admin Services, legal services, meeting room, Payroll & withholding tax, landscape services, JEA- Marina utilities, Truist credit card, property tax, Microsoft office, and Palm tree and marsh undergrowth removal, totaling \$17,790.59; Motion Carried.

The total available funds in the HWSD general fund account after disbursements as of October 31, 2025 is \$2,435,797.91. Total Projected Available funds after FY Operating and Project expenses through June, 2026 are \$2,054,170.22.

The next meeting is scheduled for Thursday, December 11, 2025.

**HARBOUR WATERWAY SPECIAL DISTRICT
RESOLUTION NO. 2025-08**

A RESOLUTION OF THE HARBOUR WATERWAY SPECIAL DISTRICT, DUVAL COUNTY, FLORIDA, AUTHORIZING PARTIAL REBATES ON NON-AD VALOREM ASSESSMENTS PAID BY PROPERTY OWNERS WITHIN THE DISTRICT ON THE 2024 ASSESSMENT ADOPTED BY THE DISTRICT THROUGH RESOLUTION NO. 2024-05; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on July 9, 2024, pursuant to notice, the Harbour Waterway Special District (“HSSD”) Board of Supervisors (“Board”), as authorized by City of Jacksonville Ordinance No. 2010-725-E (“Ordinance”), adopted Resolution 2024-05, imposing a non-ad valorem assessment on properties with the HWSD, to fund its fiscal year 2024-2025 budget; and

WHEREAS, also in accordance with the Ordinance, the Board, on April 8, 2025, adopted Resolution 2025-06 adopting its fiscal year 2025-2026 budget; and

WHEREAS, as a consequence of receipt of total revenues during fiscal year 2024-2025 together with projected revenues that will be received during the remainder of fiscal year 2025-2026, the District will have more than sufficient revenues to enable the HWSD to meet all of its financial obligations and operating expenses during the current fiscal year; and

WHEREAS, the Board has determined that it is in the public interest to provide a partial rebate of the non-ad valorem assessment to property owners in the HWSD who are in compliance with HWSD Waterway Rules and Regulations and have paid the non-ad valorem assessment billed to them by the City of Jacksonville Tax Collector in November 2024, based on Resolution No. 2024-05 (hereinafter “2024-2025 Assessment”), rather than placing those funds in reserve or re-appropriating those funds to another purpose; and

WHEREAS, through this Resolution, the Board establishes the pre-requisite conditions for payment of the rebate and the process for payment of the rebate.

NOW THEREFORE, Be it Resolved by the Board of the HWSD that:

Section 1. The Board authorizes a rebate payment to property owners in the District who have paid the 2024-2025 Assessment. The rebate payment for each parcel within the HWSD shall be as shown on the attached Exhibit "A".

Section 2. Only property owners who are in compliance with HWSD Waterway Rules and Regulations and have paid the 2024-2025 Assessment shall be eligible to receive the rebate payment shown on Exhibit "A", which does not include holders of tax certificates related to the 2024-2025 non-ad valorem assessment.

Section 3. In order to receive the rebate payment, the property owner holding title to a parcel shown on Exhibit "A" shall provide a receipt or other proof to the District Manager for the HWSD that the 2024-2025 Assessment has been paid for the parcel for which the application is submitted.

Section 4. The rebate payment will be made only to the person(s) or entity shown as owner of the property on the current records of the City of Jacksonville Property Appraiser.

Section 5. No interest will be due or payable from the District to any property owner on any rebate payment, regardless of when a request for payment of same is received by the District or when a rebate payment is made to the appropriate property owner.

WHEREAS, Ordinance 2025-727 proposes an amendment to the purchase agreement in Ordinance 2023-351 that is beneficial to the District.

NOW THEREFORE BE IT RESOLVED by the Board of the District:

Section 1. The Chairman of the Board or the Secretary/Treasurer or the District Manager is authorized to negotiate and execute all closing documents as required per Ordinance 2025-727 on behalf of the District.

Section 2. This Resolution shall become effective upon passage.

20 **WHEREAS**, effective as of June 30, 2023 and as previously
21 authorized by Ordinance 2023-351-E (the "Ordinance"), City and the
22 Harbour Waterway Special District (the "District") entered into an
23 Agreement for Sale and Purchase (the "Original Agreement"), attached
24 hereto as **Exhibit 1**, pursuant to which the City conveyed certain real
25 property to the District for the development of a park and
26 conservation area, open and available to the general public in
27 perpetuity (the "Park Property"); and

28 **WHEREAS**, as consideration for the conveyance, the District
29 agreed to undertake certain performance obligations related to the
30 Park Property, with completion required within three (3) years of the
31 date the Park Property was conveyed to the District; and

1 **WHEREAS,** in the interim since the adoption of the Ordinance,
2 JEA and JAXPORT announced their intent to begin construction of a
3 major project, estimated to require two to three years for completion,
4 for the purpose of elevating and partially relocating existing
5 electrical transmission lines and related towers (the "JEA Project"),
6 including on and over certain real property owned by the District
7 that is adjacent to the Park Property; and

8 **WHEREAS,** JEA has requested, and the District has agreed to
9 provide JEA with temporary use of and access through the Park Property
10 as required to enable JEA to construct and complete the JEA Project;
11 and

12 **WHEREAS,** the JEA Project will entail major construction
13 activities on the District's adjacent property as well as temporary
14 impacts on the Park Property which will be used as an access and
15 staging area for construction of the JEA Project; and

16 **WHEREAS,** although the three (3) year period allotted for the
17 District's completion of its performance obligations has not yet
18 expired, it is advisable now to extend the time for completion of
19 such obligations from three (3) years to six (6) years, as
20 memorialized in the proposed first amendment to the Original
21 Agreement, given the impacts to the Park Property and the District's
22 adjacent property arising from the JEA Project; now therefore

23 **BE IT ORDAINED** by the Council of the City of Jacksonville:

24 **Section 1. Approval and Authorization to Execute a First**
25 **Amendment.** There is hereby approved, and the Mayor, or her designee,
26 and the Corporation Secretary are hereby authorized to execute and
27 deliver, for and on behalf of the City, a First Amendment to Agreement
28 for Sale and Purchase Between City of Jacksonville and the Harbour
29 Waterway Special District (the "First Amendment"), in substantially
30 the same form as attached hereto as **Exhibit 2** to extend the time for
31 completion of the District's performance obligations under the

1 Original Agreement from three (3) years to six (6) years due to
2 expected impacts from the JEA Project.

3 **Section 2. Oversight Department.** The Parks, Recreation and
4 Community Services Department shall provide continued oversight and
5 administration of the Original Agreement and the First Amendment.

6 **Section 3. Effective Date.** This Ordinance shall become
7 effective upon signature by the Mayor or upon becoming effective
8 without the Mayor's signature.
